

TO WHOM IT MAY CONCERN

CARGO WITH FINAL DESTINATION MALI

We have the pleasure to inform you that our company has been nominated as Subagent by the company Frabemar UK, who is representing the Malian Shippers Council as general agent worldwide, for the issuance and validation for BESC's (Bordereau Electronique de Suivi des Cargaisons) for cargoes with final destination Mali for ports of loading located in Germany, Poland, Lithuania, Latvia, Estonia, Scandinavia, Russia, Belorussia, Denmark, Austria.

The BESC is a compulsory document for any shipment with final destination Mali. Every BL which covers cargo destined to Mali, must be covered by a BESC, to allow cargo to be carried from POD to Mali border control and for the consignees to clear their cargo when entering Mali. This control will be implemented by the Exclusive Representative at POD Satralog who will clear the BESC and permit the on-carriage of the goods to Mali.

Incomplete requests will not be taken into consideration, and no BESC number will be released without payment. To this effect the web site www.cmc-besc.net has been activated in which all necessary information are available i.e.:

- Procedures;
- CMC Circular message;
- Worldwide Agents network authorized to deliver the BESC;

PROCEDURE:

- 1) An applicant has to communicate the following information:

Application form (please see attachment)

B/L copy as separate pdf

Copy of freight invoice as separate pdf

Copy of commercial invoice including FOB value as separate pdf

- 2) The Agent inserts the data into the BESC SYSTEM, issues an invoice and sends a copy of BESC draft to be confirmed by the applicant

- 3) Once the applicant has made the payment, the Agent communicates the BESC number to be inserted on the BL document

- 4) On vessel's departure, the applicant transmits to the agent a copy of the final BL which is being uploaded into the BESC SYSTEM and proceeds with eventual amendments / corrections needed.
- 5) In case of no reply from the applicant, the BESC draft will be considered as confirmed 5 days after it was sent to the applicant or 5 days after vessel's departure from the first POL conditioned to payment reception.
- 6) The Agent validates the BESC and transmits it by e-mail to the applicant
